A vibrant democracy demands collaborative relationships. My research focuses on when, why, and how individuals with diverse forms of expertise and lived experience work together to solve problems, such as improving the health of their local community and directly addressing many of the social determinants of health. The types of collaborative relationships I focus on are largely between researchers and community leaders such as nonprofit practitioners, advocates, organizers, and local policymakers. In addition to advancing the study of expertise in civic life and the science of collaboration, I spend considerable time putting my and others' research findings into practice as president of research4impact, a nonprofit organization that connects researchers, practitioners, and policymakers. Since 2018 I have created over 350 new collaborative relationships and also led dozens of workshops across the world to help people surface the unmet desire to collaborate in their organizations, educational institutions, and workplaces, and then meet it.
